WHEREAS, Butch Conover, Commissioner of Public Works for the City of Rome, has recommended that the City of Rome enter into an inter-municipal agreement with the Town of Verona whereby the City of Rome agrees to snow plow approximately 2,024 feet of Zingerline Road and 6,082 feet of Heelpath Road in the Town of Verona, New York, and whereby the Town of Verona, New York agrees to snow plow and roadside mow a section of Brown Road from the Verona Town line to Greenway New London Road, a distance of approximately 4,000 feet, said agreement to commence effective upon execution and expire three years thereafter; now, therefore

INTERMUNICIPAL AGREEMENT

THIS AGREEMENT, made this _____ day of _____, 2017, by and between **THE TOWN OF VERONA**, a municipal corporation organized under the laws of the State of New York, with offices located at 6600 Germany Road, Verona, New York, 13478, hereinafter referred to as "**TOWN**", and **THE CITY OF ROME, NEW YORK**, a municipal corporation organized under the laws of the State of New York, with offices located at Rome City Hall, 198 North Washington Street, Rome, New York, 13440, hereinafter referred to as "**CITY**".

WITNESSETH:

WHEREAS, the **CITY** wishes to engage the services of the **TOWN** to assist in the snow plowing and roadside mowing required by the **CITY**, and

WHEREAS, the **TOWN** possesses the requisite personnel and expertise to assist the **CITY** in the snow plowing and roadside mowing services required by the **CITY**,

WHEREAS, the **TOWN** wishes to engage the services of the **CITY** to assist in the snow plowing and roadside mowing required by the **TOWN**, and

WHEREAS, the **CITY** possesses the requisite personnel and expertise to assist the **TOWN** in the snow plowing and roadside mowing services required by the **TOWN**,

NOW, THEREFORE, in consideration of the mutual covenants contained herein, the parties hereto agree as follows:

1. The term of this Agreement shall commence upon execution and expire three years thereafter or upon termination by either or both parties.

2. The **CITY** agrees to snow plow approximately 2,024 feet of Zingerline Road and 6,082 feet of Heelpath Road in the Town of Verona for **TOWN**.

3. The **TOWN** shall snow plow and roadside mow a section of Brown Road from the Verona Town line to Greenway-New London Road, a distance of approximately 4,000 feet, for **CITY**, which is more specifically set forth in Exhibit A which is attached and made part of this Agreement.

4. It is expressly agreed that the relationship of the **TOWN** to the **CITY** shall be that of an independent contractor. The **TOWN** shall not be considered an employee of the **CITY** for any purpose including, but not limited to, claims for unemployment insurance, workers compensation, retirement or health benefits.

5. The **TOWN** agrees to indemnify and hold harmless the **CITY** from and against any and all claims, demands and lawsuits for personal injury, including death, and property damage, which may arise from or be attributable to **TOWN'S** negligence or lack of care in its performance under the terms of this agreement.

6. It is understood that this instrument represents the entire Agreement between the parties hereto; that all previous understandings are merged herein; that no modifications hereof shall be valid unless in writing and signed by both of the parties hereto.

7. 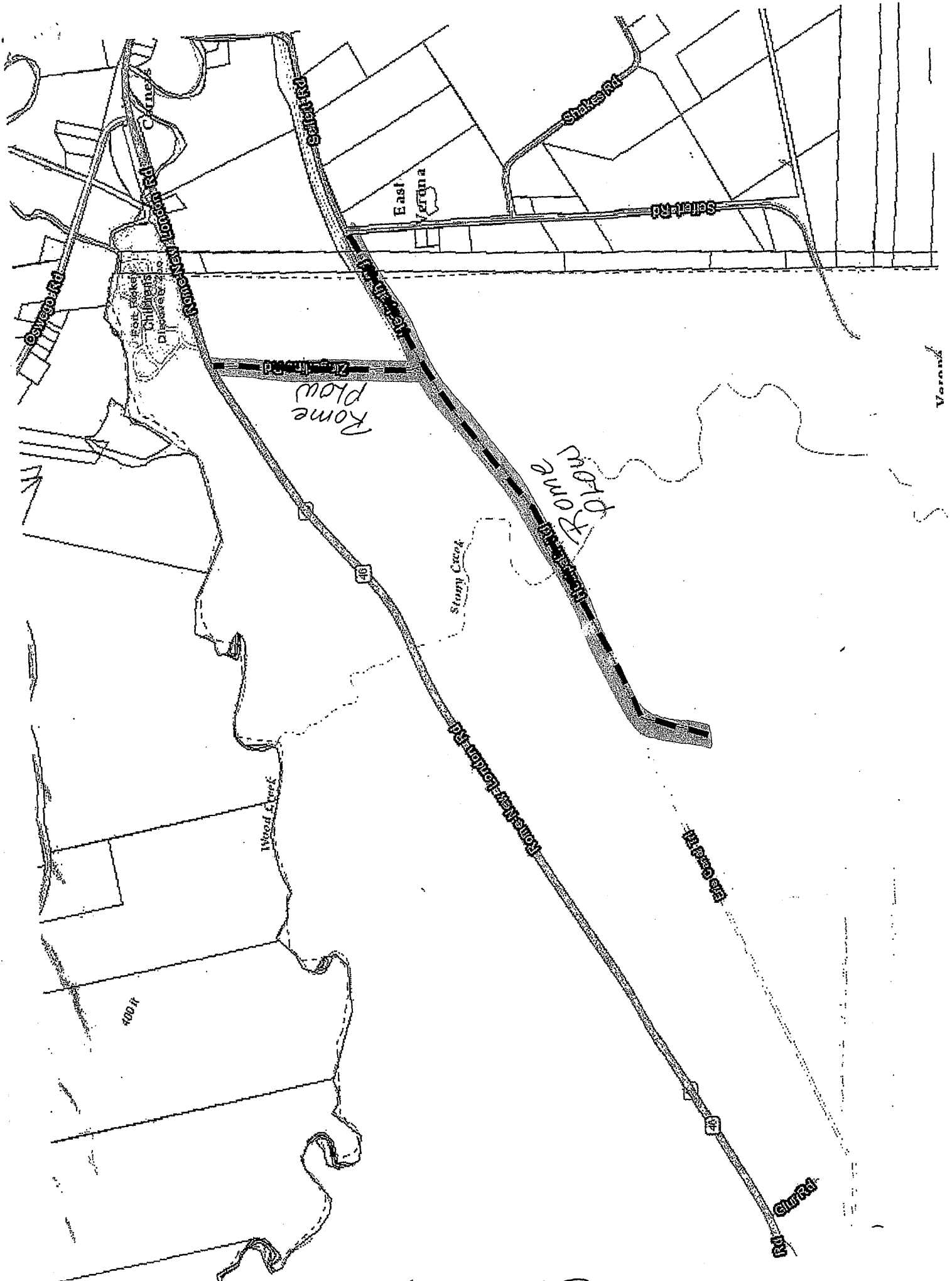

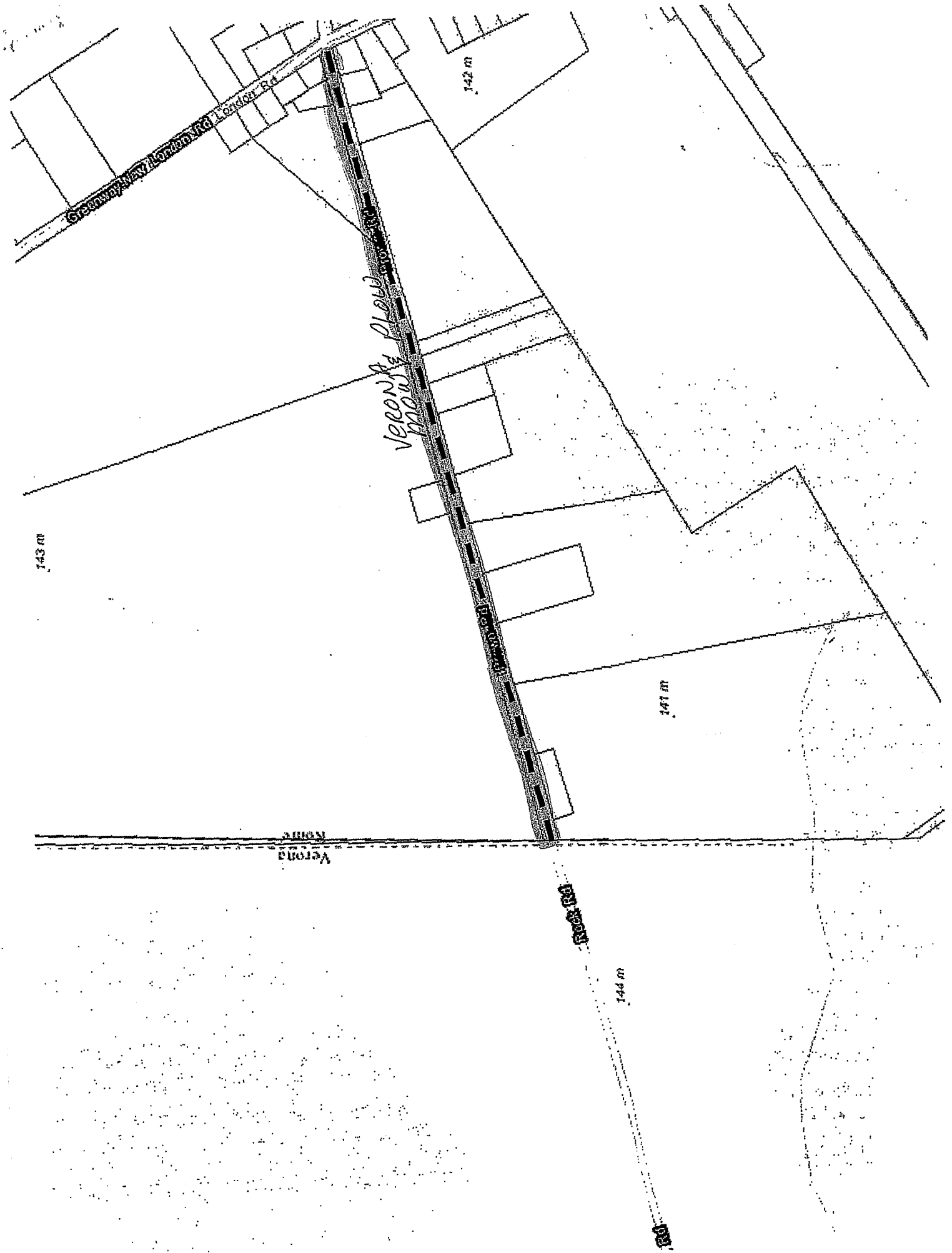

WHEREAS, any Property not obtained by an owner, finder or other person having claim to said Property and in the event said Property is unsuitable for City use, the City may deem said Property “surplus property” under §2-384 of the Rome Code of Ordinances; and

WHEREAS, pursuant to Rome Code of Ordinances §2-384(c)(2), surplus property having a value of less than five hundred dollars (\$500.00) may be disposed of by sale in the open market, upon public notice of the sale to be published in the official newspaper, at least seven (7) days prior to the sale; and

WHEREAS, Ronald Crever operates a charitable not-for-profit organization called “Bikes for Kids” in the City of Rome, that obtains and repairs used and junked bikes, which are then donated to children throughout the City of Rome; and

WHEREAS, Chief Kevin Beach of the Rome Police Department, is of the opinion that the best interests of the City of Rome and its citizens are furthered by the sale of the surplus lost bicycles to the not-for-profit organization “Bikes for Kids”; therefore, warranting the waiver of the procedures of Rome Code §2-384(c)(2) and deeming a direct sale of the surplus lost bicycles to “Bikes for Kids” reasonable under New York State Personal Property Law §253(5); now, therefore,

BE IT ORDAINED, by the City of Rome Common Council that the City Clerk be and hereby is authorized to issue public notice to be published in the official newspaper of the City of Rome that lost property, consisting of lost or abandoned bicycles, will be sold via direct sale to “Bikes for Kids” within fourteen (14) days of said publication. The publication shall further advise that only those persons in possession of the following Rome Police Department receipts, may assert a claim of ownership as finder of the applicable lost bicycle, pursuant to the listing attached hereto and by this reference made a part hereof as Exhibit A, and that failure to assert a claim of ownership within said fourteen (14) day period will be deemed a waiver of the rights of ownership and will permit the City of Rome to sell the applicable bicycle via direct sale; and

BE IT FURTHER ORDAINED, by the Common Council of the City of Rome, New York, that the rules and regulations for the sale of surplus property as set forth in the Rome Code of Ordinances §2-384(c)(2), be and are hereby waived for the sale of any surplus lost bicycles not obtained by persons with legitimate rights as owners, finders or other claims of ownership, as evidenced by a Rome Police Department receipt; and

BE IT FURTHER ORDAINED, that, upon the expiration of fourteen (14) days from the date of publication of said notice, the Board of Estimate & Contract may approve the sale of the surplus property to Ronald Crever of "Bikes for Kids" in the City of Rome, under the express condition that said bicycles not be sold for profit or gain, and under such other terms and conditions as the Board of Estimate & Contract deems appropriate.

WHEREAS, pursuant to New York State Personal Property Law (hereinafter "PPL") §253, the Rome Police Department is charged with the responsibility of receiving and storing lost property found within the City of Rome, New York, and

WHEREAS, pursuant to New York State PPL §251(1) & (3) "lost property" includes lost, mislaid or abandoned tangible personal property where said property is not claimed for at least six (6) months; and

WHEREAS, in the course of the last twenty-four (24) months, the Rome Police Department has received and stored lost property, consisting of thirty-six (36) lost or abandoned bicycles, hereinafter referred to as "Property"; and

WHEREAS, the Rome Police Department has estimated the value of each of the bicycles to be less than seventy-five dollars (\$75.00), meaning, pursuant to PPL §253(7), that the Property has only salvage value and the Rome Police Department need only store the Property for three (3) months; and

WHEREAS, by storing the Property a minimum of twelve (12) months, the Rome Police Department has stored the Property for longer than the required retention period, and said Property has not been claimed by any person, including any owner or finder, thereby allowing the Property to be disposed of as set forth at PPL §§253(5) & (8); and

WHEREAS, under PPL §253(8), in order to properly effectuate the sale of the Property, the Rome Police Department must notify any person asserting rights to any lost bicycle as owner, finder or under any other claim, that failure to exercise said right will permit the City of Rome to sell the Property as provided for at PPL §253(5); and

WHEREAS, under PPL §253(5), because the Property has only salvage value, the Rome Police Department may sell the Property in such a manner reasonable under the circumstances; and
