QUESTIONS AND ANSWERS

1. Please provide forms for the Bidders Qualifications Statement and the Non-Collusive Affidavit.

Response: These forms are attached to this addendum.

2. Is there any consideration to extend the construction date given the time-of-year limitations on in-stream work and the delay in the bid opening?

Response: Completion date remains unchanged (November 15, 2026). Onsite construction activities shall be suspended from November 15th to April 1st each year for a winter shutdown. The duration that construction is suspended will not be factored into assessing liquidated damages if any.

3. Keyed note #2 on E-6: "Coordinate upgraded service with utility. Provide new overhead secondary service and utility meter. Coordinate exact size of service cable with utility". Typically National Grid provides all secondary conductors from their transformer over to a customer's weather head. In which they would "splice" the conductors at this weather head, after the AHJ and/or third-party electrical inspector approves. Can it be confirmed that the EC is to provide/install the secondary conductors per the drawings? Perhaps the allowance dollar amount on item #3 of the Contract IE's bid form is supposed to carry this?

Response: Bid Item Number 3, National Grid Service Upgrade allowance includes coordination with the Utility and providing all connections/equipment required in support of the new service meeting National Grid requirements. Coordination with the Utility will govern what the contractor needs to supply in support of the new service.
